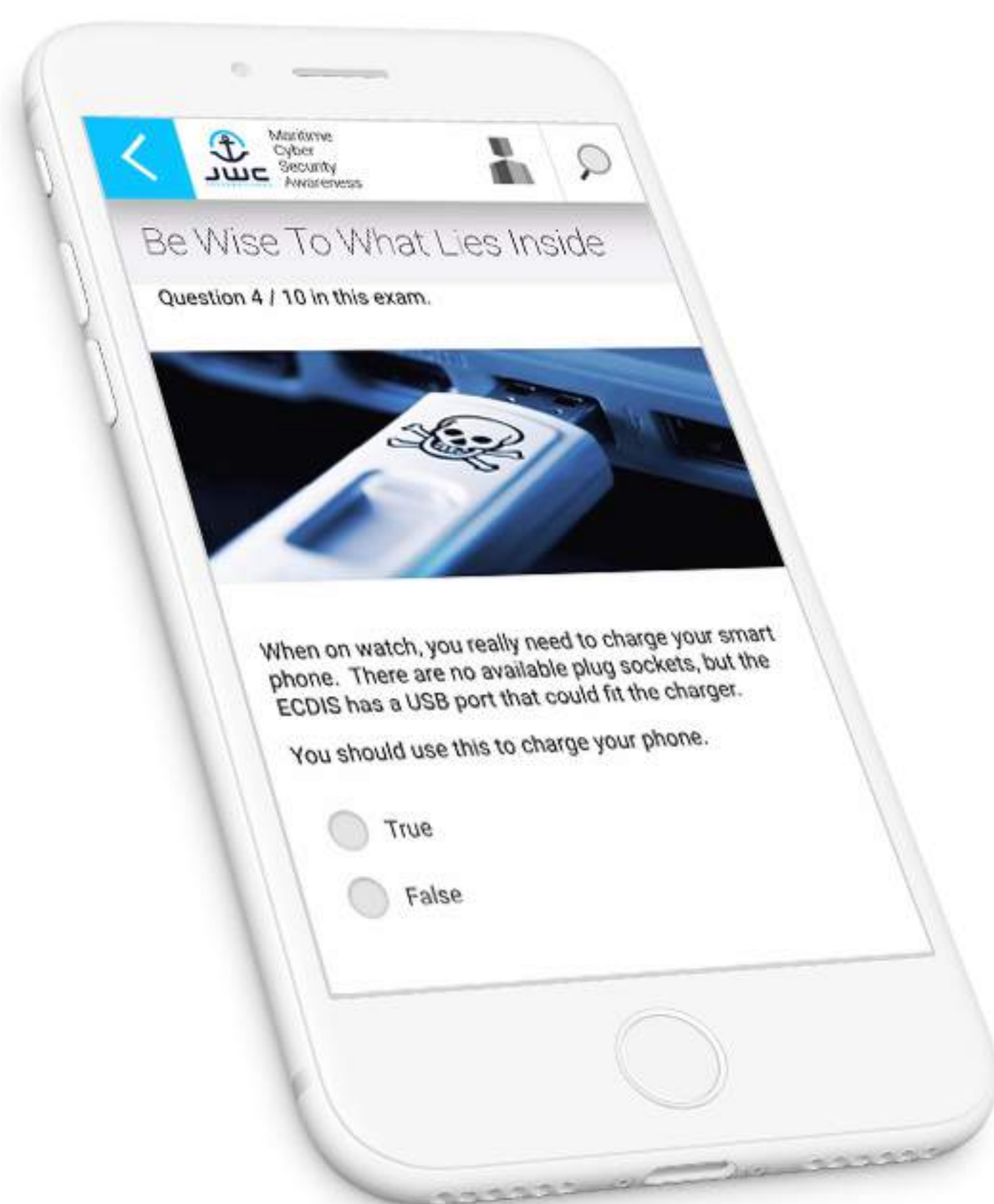


Target Audience
